

COMMUNITY PUBLIC AND NONPROFIT RESOURCES

ANIMAL CONTROL: Animal services and enforcement agencies offer information and assistance on the following: sick/injured, barking/nuisance dogs, rodents, stray/feral, license/registration, dog bites, neglect/abuse, spay/neuter, aggressive breeds prohibition. For residents living in incorporated areas, contact cities directly.

HOUSING PROGRAMS: Some counties (not all) offer rent assistance (Section 8), mobilehome rehabilitation grants or loans, and utilities payment assistance. Some counties' **WEIGHTS & MEASURES** depts. will inspect the accuracy of residential utility meters.

LEGAL RESOURCES: Most legal resources are provided by community-based, non-profit organizations.

SENIOR AND SOCIAL SERVICES: Some counties (not all) and non-profits offer services, grants or vouchers for medical care, food, in-home care, etc. United Way is a central agency for numerous nonprofit organizations.

VETERANS SERVICES: Some veterans may be eligible for mobilehome loans, or grants to adapt a home for service-related disabilities. Also, see calvet.ca.gov.
